**RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK AND IDEMNITY AGREEMENT** IN CONSIDERATION of being allowed to participate in any way in the UNITY PINK MOTORCYCLE RIDE:

1. I UNDERSTAND AND AGREE that, although I have been supplied with certain information on the prescribed course, the nature of the ride does not permit me to inspect the prescribed course or any portion of the prescribed course or the immediately adjacent areas thereof with which I may come in contact with during the motorcycle ride prior to my participation in the ride. I understand and agree that at any time to be UNSAFE, I will immediately take all necessary precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further in the ride.
2. I UNDERSTAND that participation in the ride involves RISK AND DANGERS, BOTH KNOWN AND UNKNOWN, of serious BODILY INJURY, including PERMANENT DISABILITY, PARALYSIS, DEATH, and property damage.
3. I ASSUME FULL RESPONSIBILITY FOR ANY AND ALL SUCH RISKS OF BODILY INJURY OR DEATH TO ME, OR OF PROPERTY DAMAGE TO MY PROPERTY arising out of or related to my participation in the ride, even if caused, in whole or in part, by THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
4. I HEREBY RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE the promoters, participants, officials, car owners, drivers, crew members, rescue personnel, sponsors, advertisers, owner, and lessees of premises used to conduct the ride, premises and event inspectors, surveyors, underwriters, consultants, and others who give recommendations, directors, officers, agents and in risk evaluation or loss control activities regarding the premises or ride and each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "RELEASEES", FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO ME OR MY PROPERTY OR RESULTING IN MY DEATH ARISING OUT OF OR RELATED TO MY PARTICIPATION IN THE RIDE WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
5. I HEREBY AGREE TO DEFINE, IDEMINFY AND SAVE AND HOLD HARMLESS THE RELEASES and each of them from any loss, liability, damage, or cost that may occur due to claims brought against the releases arising out of my injury or death while I am participating in the ride and WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
6. I HEREBY AGREE that this agreement shall be binding and enforceable against me, my personal representative, agents, spouse, assigns, heirs and next of kin without limitation.
7. I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT, UNDERSTAND ITS TERMS, AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANCIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
