RELEASE AND WAIVER OF LIABILITY ASSUMPTION OF RISK AND INDEMNITY AGREEMENT In consideration of being allowed to participate in any way in the UNITY PINK RIDE: 1. I UNDERSTAND AND AGREE that although I have been supplied with certain information on the prescribed course, the nature of the ride does not permit me to inspect the prescribed course or any portion of the course or the immediate adjacent areas thereof which I may come in contact with during the motorcycle ride prior to my participation of the ride. 2. I UNDERSTAND that participation in the ride involves RISKS AND DANGERS, BOTH KNOWN AND UNKNOWN, of SERIOUS BODILY INJURY, including PERMANENT DISABILITY, PARALYSIS, DEATH, and property damage. 3. I ASSUME FULL RESPONSIBILITY FOR ANY AND ALL SUCH RISKS OF BODILY INJURY OR DEATH TO ME OR DAMAGE TO MY PROPERTY arising out of or related to my participation in the ride, even if caused in whole or in part, by the NEGLIGENCE OF THE RELEASEES. 4. I HEREBY RELEASE, WAIVER, DISCHARGE, AND COVENANT NOT TO SUE Unity Outreach ,Inc., Adamec Harley Davidson® Jacksonville/ St. Augustine, Ancient City Hog Chapter, the promoters, participants, officials, car owners, drivers, crew members, rescue personnel, sponsors, advertisers, owners and leases of premises used to conduct the ride, premises, and event inspectors, surveyors, underwriters, underwriters, consultants, and others who give recommendations, directors, officers, agents, and all for the purposes herein referred to as "RELEASEES", FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO ME OR MY PROPERTY OR RESULTING IN MY DE ARISING OUT OF OR RELATED TO MY PARTICIPATION IN THE RIDE WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. 5. I HEREBY AGREE TO DEFINE, IDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them from any loss, liability, damage, or cost that may occur due to claims brought against the releases arising out of my injury or death while I am participating in the ride and WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. 6. I HEREBY AGREE that this agreement shall be binding and enforceable against me, my personal representatives, agents, spouse, assigns, heirs, and next of kin without limitations. 7. I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT, UNDERSTAND ITS TERMS, AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANCIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. 8.
